



Xtreme Warrior Race

1. **Acceptance of Terms** By registering for, attending, or participating in XTREME WARRIOR RACE ("XWR"), each Participant agrees to be bound by these Terms and the Official XWR Rulebook. Failure to comply may result in penalties, disqualification, or removal without refund.
2. **Eligibility** Participants must be at least 16 years old on race day. Participants under 18 must have written parental or guardian consent. Participants warrant they are physically fit to compete in a high-intensity endurance event.
3. **Registration and Payment** Registration is valid only after full payment. Registrations are personal and non-transferable unless approved by the Organizer. Entry fees are non-refundable except where required by law.
4. **Assumption of Risk and Waiver of Liability** Participants acknowledge that XWR involves inherent risks including injury, heat illness, collisions, slips, falls, and environmental hazards. Participants voluntarily assume all risks and release the Organizer and affiliates from liability to the fullest extent permitted by law.
5. **Medical Authority** Participants confirm they are medically fit to compete. The Organizer may remove any Participant deemed unsafe by medical staff. If one member of a Doubles team is withdrawn, the team must withdraw.
6. **Event Modifications or Cancellation** The Organizer may modify, delay, or cancel the event due to safety, weather, or force majeure. Refunds are not guaranteed in such cases.
7. **Conduct** Participants must act respectfully toward judges, staff, volunteers, and other athletes. Cheating, abuse, or disruptive behavior may result in disqualification or future bans.
8. **Judging** Judges' decisions are final. Disputes must be raised respectfully through official channels.
9. **Equipment and Safety** Closed-toe shoes are required. Headphones, phones, or personal recording devices are prohibited while competing. Only approved equipment may be used.
10. **Media Rights** Participants grant the Organizer a perpetual license to use photos, videos, and likeness for promotional and commercial purposes without compensation.
11. **Data and Privacy** Personal data may be collected for registration, timing, and results. Data will not be sold to third parties without consent, except where required by law.

12. Intellectual Property All XWR names, logos, and branding are the property of the Organizer. Unauthorized use is prohibited.

13. Results Official rankings are based on chip time and completion of all stations in order. Results may be published publicly.

14. Amendments The Organizer may update these Terms at any time. Participants are responsible for reviewing changes.

15. Governing Law: These Terms are governed by the laws of the jurisdiction where the event takes place.
